Status of SCO and BRICS Summits

BRICS

- The BRICS Sports Ministers Meeting was held on 04th June, 2025 at Brasilia, Brazil. The Indian side was led by the Ambassador of India to Brazil. Further, Ms. Meenu Singh Bist, Director and Sh. Wayal Sachin Pralhadrao, Deputy Director, KIC, SAI participated in the meeting from the Department.
- In the BRICS Sports Ministers Meeting; an MoU on sports cooperation was signed among the BRICS Member States.

SCO

- A 3-member delegation consisting of Sh. Sanjay Rastogi, AS & FA, Dr. Sandeep Rewaji Rathod, Director and Sh. Surendra Yadav, Under Secretary attended the Meeting of Heads of SCO Member States' Ministries and Agencies Responsible for the Development of Physical Culture and Sport and related supporting activities held on 19th – 23rd May, 2025 in Harbin city, Heilongjiang province, China.
- The China side has shared the Outcome documents (Minutes and Dissenting Opinion) with this Department through MEA vide email dated 09th June, 2025 in respect of the 4th Session of Heads of Ministries and Agencies responsible for the development of Physical Education and Sports of the Shanghai Cooperation Organization Member States held on 21st May, 2025 in China.
