## **General Conditions/information:-**

1. The Qualifications prescribed should have been obtained from recognised Universities/Institutions.
2. Candidates should ensure that he/she possesses the required educational qualification/experience in the relevant area i.e., for deputation/transfer or Direct Recruitment, on the last date of receipt of applications.
3. The selected candidates (in case of deputation) initially will be on deputation for a period of 03 years extendable upto 07 years with the approval of the Competent Authority consequent upon consent of the deputationist and NOC from his/her parent organization and other necessary clearances which may be required in such situation.
4. The selected candidate (on deputation) will be governed by foreign service deputation terms with NDTL and his/her pay and terms and conditions of service shall be governed by Govt. of India, DOPT OM No. 6/8/2009-Estt. (Pay –II) dated 17/06/2010 as amended from time to time.
5. The period of experience in a discipline/area of work, wherever prescribed, shall be counted after the date of acquiring the minimum educational qualification prescribed for the post.
6. Wherever grades are awarded by Universities/Institutes in CGPA/SGPA/OGPA etc. system, candidates are requested to convert the same into percentage based on the formula adopted by the University/Institute and mention the percentage at the appropriate column in the application form.
7. Candidates working in Government/Semi Govt./Autonomous Organisations/PSUs should apply through proper channel and to reach us on time. (However, if called for interview, the candidate would have to produce a “No Objection Certificate” from the employer”)
