**ORDER**

Sub: Election of Judo Federation of India (JFI) held on 10<sup>th</sup> February, 2018 and annual recognition for 2018 - regarding.

\*\*\*\*\*

Judo Federation of India (JFI) was granted recognition by this Ministry as a National Sports Federation for promotion and regulation of Judo Sport in the country. Annual Recognition was not granted to JFI since 2011 due to non-compliance of Ministry's guidelines on good governance including age and tenure of office bearers.

2. A Writ Petition No.W.P.(C) No.10353 of 2017 & CM No.42203 of 2017 was filed by Shri Yashpal Solanki V/s UOI & Ors. in the High Court of Delhi at New Delhi seeking election of JFI as per the provisions of National Sports Development Code of India, 2011 (NSDCI). Hon'ble Delhi High Court vide order dated 24/11/2017 appointed Dr. Nivedita P. Haran, IAS (Retd.) as Returning Officer (RO) to hold the elections of Judo Federation of India (JFI). Accordingly, the election of JFI was conducted by the RO at New Delhi and report of the said election was submitted by the RO. The election report of JFI was examined in the Ministry. The names of persons who were elected for the term of 2017-2021 is given in the annexure. Subsequently, vide order dated 9/4/2018, Hon'ble High Court has, inter-alia, ordered as under:-

“ In the light of the above, we accept the report dated 19<sup>th</sup> February, 2018 of Dr. Nivedita P. Haran, IAS (Retd.) qua the elections to all posts except the post of General Secretary which post is kept in abeyance for the time being”.



2.	Shri B. Kailasram Yadav	Treasurer - 15/8/1968 (1 <sup>st</sup> Term)

4. Consequent to the above, the annual recognition of JFI for the year 2018 is also renewed.


