**Sub:- Suspension of Indian Powerlifting Federation (IPF)**

Sir,

Indian Powerlifting Federation (IPF) has been granted recognition by the Ministry as National Sports Federation for promotion of Powerlifting sport.

2. AND WHEREAS it has been laid down in the National Sports Development Code in India 2011 that "Suspension by the concerned International or Asian Federation on any ground whatsoever" is a ground for suspension of the recognition granted by the Government to the National Sports Federation.

3. AND WHEREAS the Asian Powerlifting Federation recognised by International Powerlifting Federation (the international body for Powerlifting sport to which Indian Powerlifting Federation is affiliated) vide its letter dated 07.09.2017 has dissolved the current body/office bearers of IPF and formation of new adhoc body of IPF with Shri Rajesh Tiwari as President.

4. AND WHEREAS under the given situation the Government is left with no choice but to suspend the recognition of Indian Powerlifting Federation in accordance with the provisions under clause I (i), (vii), (xi) of Annexure-III of Scheme of Assistance to NSFs, with immediate effect till further orders.

5. This has the approval of competent authority.
