**Subject: Renewal of Annual Recognition to Shooting Ball Federation of India- reg.**

Sir,

The matter regarding renewal of recognition to Shooting Ball Federation of India (SBFI) has been examined. The last election of office bearers of the Federation were held on 30<sup>th</sup> December, 2016 for the term 2016-20 and same was taken on record by the Ministry.

2. The elections of the Executive Committee of SBFI for the next term i.e. 2020-2024 have been also held on 18.10.2020. Election report of Shooting Ball Federation of India held on 18.10.2020 has been received in the Ministry and the same is under examination in light of various guidelines issued by the Ministry.

3. Upon consideration of the entire matter, it has been decided to renew the recognition of Shooting Ball Federation of India up to 31.12.2020.

4. It has been noticed that constitution / MoA of Shooting Ball Federation of India needs to be aligned with the provisions of the National Sports Development Code of India, 2011 (Sports Code). Accordingly, the Shooting Ball Federation of India is required to make categorical affirmation of the provisions of the Sports Code in its constitution within 6 months so as to bring the same fully in line with the Sports Code. The Federation is also required to take necessary steps for uploading of the information in compliance to the instructions as contained in this Ministry's letter no. 9-7/2014-SP.1 dated 26.02.2015 on suo-moto disclosure within 3 months' time (copy enclosed).
